

Data Protection



The data is handled by PARTTEAM & OEMKIOSKS in compliance with all legal obligations.

The processing of personal data shall indeed be strict, transparent and fair. This way, it shall only occur for the purposes determined at the time of data collection. It can't, therefore, be used subsequently for other purposes, even if compatible.

The data, which must be limited and used by PARTTEAM & OEMKIOSKS only when really necessary, must be accurate, updated and kept securely and only for the period reserved for the purpose of the treatment.


It is forbidden to offer or receive, under any and all circumstances, and regardless of the value, money, checks and other goods subject to legal restrictions.




Corporate Responsibility
